two ways: first by giving just two hours of your time to help in one of these schools (or additional schools if we get enough volunteers), and second, by contributing books to be donated to the District of Columbia Public Schools.

The act of giving to others brings with it its own rewards in feelings of satisfaction and a sense of accomplishment. Surveys show that the major reason people give for not volunteering is lack of time. Despite the lack of time, 48.8 percent of Americans do volunteer in some way. Our conference projects have been planned to allow participation by even the busiest attendees.

#### **VOLUNTEERS IN THE PUBLIC SCHOOLS**

On Wednesday, July 21, two teams of volunteers will work in the library at Adams Elementary School from 10-12 and 12-2 helping the librarian rebuild the library after its complete dismantling for three years. Help is needed at Adams ES making catalog cards, labeling books, shelf reading and weeding the collection. D.C. school librarians typically do not have any staff to help with library maintenance tasks and they teach a full load, plan lessons, attend meetings, etc., leaving little time for keeping up with the collection. The librarian at the School Without Walls needs help inventorying their library collection. The School Without Walls is a senior high school that uses the city as a classroom and educational training ground for students by giving them internship experiences and using community resources as an integral part of the curriculum. There are other schools that also need volunteer help if we have enough volunteers. THE LAW LIBRARY HAS BEEN REFERRED TO AS THE HEART OF THE LAW SCHOOL and it is no doubt a vital part of a law firm as well. AALL President Jim Heller has stated that while the library is recognized as the heart of these organizations, he considers the paraprofessional staff to be the heart of the law library. Recognizing the important role played by paraprofessionals in law library settings, President Heller asked Steve Margeton, Director of the Law Library at Catholic University, and myself to design a new program for the AALL annual meeting that would address the needs of paraprofessionals. From this the Paraprofessional Forum was born!

The Forum is designed to provide practical knowledge that will be useful to paraprofessionals regardless of their work setting. A variety of topics will be covered at different levels and attendees will be able to select from two separate programs in each of four program slots throughout the day. In addition, we've tried to give attendees a flavor of the regular AALL Annual Meeting and an opportunity for networking. Our speakers have proven experience in their areas of expertise and several of them began their library careers as paraprofessionals.

some of the new technologies that are available to better understand the relationships between paraprofessionals and technology. Identifying opportunities to use technology wisely and coping with the impact of change will be emphasized.

Topics Covered Will Include: changes in life as we knew it; managing the change-not just surviving; technology's impact on library procedures.

### PROGRAM F: THE WORLD OF THE INTERNET IN THE LIBRARY

Learning Outcome: Selected Internet library applications and sites will be identified and their effect on library paraprofessional work will be discussed.

Topics Covered Will Include: how it can change your work life - a look at applications; push/pull technology; electronic receipt of publications routing in the 21st century; how to get the most from the Internet in your job;

### PROGRAM G: SUCCESSFUL DEALINGS WITH MANAGERS/UP THE HIERARCHY

Learning Outcome: Attendees will learn the basics of organizational structure and receive tips on effectively applying this knowledge to their role in their organization.

Topics Covered Will Include: working with professionals - how to be effective in your setting; improving your working relationships; earn the respect you deserve; paraprofessionals with professional duties.

#### **PROGRAM H: MANAGING OTHERS**

Learning Outcome: Special skills are needed to manage others effectively. These skills will be identified and applied to a library setting.

Topics Covered Will Include: supervision and management; working effectively with student workers and clerks; team building for success; motivating workers for effectiveness.

In addition to the formal learning opportunities, participants in the Forum will join the regular AALL convention at special tables for the Opening Lunch and after lunch will have an opportunity to visit the Exhibit Hall for dessert and a quick look at some of the vendors.

Participants able to remain after the close of the forum will be encouraged to form a group for a Dutch Treat dinner and networking, and will also be invited to the West Group party that evening.

Whether the attendees are comfortable as a paraprofessional or interested in possibly pursuing a graduate degree, the Paraprofessional Forum will provide an opportunity for developing some very useful job skills and career tools.

**CALL TO ORDER:** The meeting was called to order by President Ahearn at 9:14 a.m.

MINUTES: The motion to accept the February minutes as corrected carried.

#### **OFFICER'S REPORTS**

**PRESIDENT'S REPORT:** C. Ahearn reported that the AALL nominations committee is seeking nominees for consideration for the 1999-2000 slate.

In-depth discussion on revisions to the Procedures Manual was lead by Bob Oaks. The proposed revisions will be mailed to the Board before the May 5th, 1999 meeting so the Board can be prepared to vote based on today's discussions.

#### **OFFICER'S REPORTS**

PRESIDENT'S REPORT: The Public Outreach committee requested permission to donate between \$500 - \$1,000 from their budget to the D.C. Public Library MLK branch. They also proposed presenting a plaque to Paul Mills in recognition of his support of the LLS-DC Public Outreach Committee efforts. The Public Outreach Committee hopes to give the plaque and the donation gift at the closing banquet. A motion to approve the award of a plaque and donation up to \$1,000 from the Public Outreach Committee to the D.C. Public Library carried.

A request was received from Kate Martin, Cochair of the AALL Local Advisory Committee, for \$600 for 1/2 of the production and printing costs of a Washington Guidebook for AALL conference attendees. The Board requested that the LLSDC logo be present and that we have equal representation with the vendor who is also supporting the Guidebook. A motion to approve a \$600 contribution to support the Guidebook carried with one abstention.

A request from Steve Margeton for \$300 to help support the AALL Paraprofessional Forum was discussed. A motion to authorize \$300 to support the AALL Paraprofessional Forum carried with one abstention.

The Assistant Director of the American Association of Law Schools (AALS) will be attending the AALL conference as part of the AALL VIP Program.

LLSDC received a thank you note from Malcolm X Elementary school for the donation of grocery receipts.

The revised election ballots will go out April 13th and 14th. An error in candidates and the offices they were running for was made in the earlier mailing.

AALL has begun an initiative to get LLSDC members who are not AALL members to join.

**PAST PRESIDENT'S REPORT:** Thirty participants are scheduled for the Technology Bootcamp this weekend. The handouts appear substantive and the idea that the Society might be able to sell them separate from the program was discussed.

TREASURER'S REPORT: R. Kaiser gave the account balances for all accounts as of April 13, 1999. The spread sheet reflects expenses but not revenue.

RECORDING SECRETARY'S REPORT: K. Silber reported the Grand Hyatt (near Metro Center) has been selected for the Closing Banquet. The cost to members is set at \$29, the actual cost is \$76. LEXIS has made a generous contribution to the event.

G. Van Pelt and the Scholarship Committee will meet May 4th in time for awards to be used to attend the AALL meeting.

THE MENTORING COMMITTEE OF LLSDC HAD A VERY PRODUCTIVE YEAR: half a dozen matches were made between mentors and proteges, and two educational programs were held. One focus of the Committee over the last two years has been to reach out to the local library schools. Last year the Committee sponsored Career Day at the U of MD College of Library and Information Science, and this year programs were held at each of the local library schools. Blending mentoring with recruitment has increased both name recognition and Society membership, and given members the opportunity to explore both MLS and post-MLS educational opportunities.

On November 20, 1998, the Mentoring Committee held a Legal Research Teach-In at U of MD. Librarians demonstrated the workplace challenges of a prison law librarian, technical services manager in a large law firm library, and an academic public services law librarian. Linda Hutchinson from Lexis-Nexis gave a presentation on alternative career paths for MLS degree holders and Jennifer Lane of the West Group demonstrated Computer Assisted Legal Research (CALR) on Westlaw. The West Group provided lunch.

On April 23, 1999, the Committee held a program entitled Competencies for the Law Librarian in the 21st Centurywhich was held at Catholic University and hosted by the School of Library and Information Science. The program was organized around two scholarly documents: The McCrate Report Legal Education and Professional Development: An Educational Continuum and The SLA Competencies Report. Competencies for Special Librarians of the 21st Century http://www.sla.org/professional/competency.html

#### McCrate Report

In 1992, the Task Force on Law Schools and the Profession of the American Bar Association (ABA) issued the McCrate Report. Part two of the Report sets forth 'A Vision of the Skills and Values New Lawyers Seek to Acquire'. The third skill outlined in the report is the need for lawyers to acquire a working knowledge of the fundamental tools of legal research which is the cornerstone of law librarianship. Knowledge of legal information resources is a subject area expertise for the special librarian. This expertise is only one component of the competencies necessary in special librarianship.

#### **SLA REPORT**

The Special Libraries Association (SLA) prepared a report entitled 'Competencies for the Special Librarian of the 21st Century'. This report describes the skills, education and attitudes necessary to be successful as a special librarian. The SLA report highlights two competencies necessary for special librarians to be effective in their roles: professional knowledge and personal attitudes.

**Professional Competencies:** knowledge in the areas of information resources, information access, technology management and research and the ability to use this knowledge as a basis for providing library and information services.

**Personal Competencies:** this represents the set of attitudes and values that enable librarians to work efficiently, communicate well, focus on continuing education, demonstrate the value-added nature of their contributions and survive in the new world of work.

The thesis of the Competencies program held at Catholic was that competencies for the law librarian in the twenty-first century are acquired and maintained by using one of these three formulae:

- Mastering the legal research skills outlined in the McCrate Report, plus developing the personal and professional competencies outlined by SLA;
- Mastering Technical Services skills plus developing the personal and professional competencies outlined by SLA;

 Mastering Electronic Services skills plus developing the personal and professional competencies outlined by SLA.

After the two scholarly reports were explained and the formula for competency in the twenty-first century was introduced, several law librarians made presentations. Leah F. Chanin, a living legend in the profession, spoke on developing a career path through publishing, as well as the competencies of a law library manager. Mary Katterfield explained the process of acquiring competency as a legislative specialist and Herb Somers described the challenges that one faces in acquiring and maintaining competency as an international law librarian. MaryEllen Albin did a presentation of competencies of a dual-accredited law firm librarian and Mary Wilson did a Powerpoint presentation on competencies for the law librarian from a technical service perspective. Linda Hutchinson of Lexis-Nexis gave tips on resume creation to showcase competencies. Lexis-Nexis was the corporate sponsor for the networking luncheon that followed the educational program.

Outreach at the local library schools is a practical implementation of the competencies of a spe-

cial librarian. Since personal competencies include 1) recognizing the value of professional networking and solidarity; 2) commitment to lifelong learning; and 3) personal career development, the Committee's visits to the library schools are directly aligned with the vision of these competencies which are the backbone of the special librarianship.

The mentoring committee continues to foster a commitment to competency in law librarianship. This goal has been achieved by presenting excellent programming to the membership of LLS-DC and the local library school community. Support for library and information service providers is a core philosophy of mentoring. The LLSDC members are always looking for partnerships and alliances to optimize complementary knowledge, which is why LLSDC is such a strong chapter of AALL. There is a wealth of resources to be shared and mentoring is a valuable way to build partnerships, network and give back to the profession. The next time a call for mentoring is sent out to the LLSDC membership, seriously consider answering it with a positive response. The only way the profession can optimize our collective knowledge is to mentor and share what we have learned.
